What's new at ALAMIC ?

First, let's talk about the biggest project, the complete renovation of the kitchen:

After the project with the well-known Swedish furniture store originally planned fell through due to a lack of flexibility and commitment on the part of the people involved, a local studio was commissioned and carried out the work to my complete satisfaction.

Everything went smoothly and, above all, on time, in terms of consultation, adherence to deadlines, the quality of the installation, and finally the handling of a complaint.

Delivery and installation had to be carried out within a tight time frame in June, as the ongoing rentals and the summer work breaks to avoid noise in Port Grimaud had to be strictly adhered to.

In addition to the new standard appliances, there is now a versatile "real" oven with microwave function.

Together with the comprehensive equipment, which also had to be added in the course of the classification, Provençal

the course of the classification, Provençal cuisine can be celebrated extensively in







During the summer months, the bedroom on the lower floor is now equipped with a powerful mobile **air conditioner**, which can also be used to cool the area around the bunk beds for children to a limited extent.

This is, of course, a compromise, as I have so far refrained from installing full air conditioning in ALAMIC for various reasons, which have already been explained in previous issues of "Le Port Grimaudin."


Another important improvement concerns the **Wi-Fi** in ALAMIC:

Since it now runs on a fast fiber optic connection, transfer rates of up to **500 Mbit/s** can be achieved, and it works on both floors without restrictions, even when the whole family is logged in.

This should be a matter of course, but by no means all vacation accommodations have stationary Internet access.

In France, mobile phone rates are significantly cheaper and come with a large data volume, so there is often no need for a landline connection.

Ongoing improvements are planned for 2026 as usual.



has now been classified as a two-star "meublé de tourisme**" by the French Ministry of Tourism.

To achieve this, a strict employee of this department had to work through a catalog of over 150 points, which, in addition to ensuring quality characteristics, is also designed with sustainable tourism in mind.

Since the beginning of 2025, France has had the so-called "Anti AirBnB" law, which is intended, among other things, to alleviate the housing shortage in major cities. Nice, for example, now limits permitted short-term rentals to 6 weeks per year.

Landlords are required to register their properties with the local authorities and also

need a permit to rent them out to vacationers.

For ALAMIC both of these requirements are met as a matter of course.

As a guest, you benefit from the stars because the tourist tax is now significantly cheaper – up to approx. **74% less per person** in high season.



I cannot understand why this is not always implemented on the booking portals (this change was of course communicated there)...

This classification is another important building block in securing my quality standards in the ever growing range of vacation accommodations on offer in the Gulf of St. Tropez.

And you will receive an "Early Bird" bonus of 5% until January 1, 2026!

I have been able to keep the rental prices almost unchanged from last season; taking into account the new tourist tax rates, they have even become cheaper.
